Yes, if the real estate business entity holds a real estate license and the sales agent is sponsored by that entity. In such a situation, the designated broker for the entity is still responsible for the sales agent's actions, even when the sales agent owns the licensed business entity.

Addendum for repairs

(1) A person who wishes to obtain a certificate of registration to engage in or carry on the business of a real estate agent or a motor vehicles dealer shall make an application to the registering authority concerned in such form and manner and on payment of such fee and furnishing of such security as may be prescribed.

The proposed amendments to §535.92 require three hours of continuing education (CE) to real estate sales agents or broker license renewals, the subject matter of which must be real estate contracts.
